

Dear Physician,

Every year, the Medical Society of the State of New York Division of Governmental Affairs analyzes thousands of bills that are introduced in the New York State Legislature that impact upon the ability of physicians in New York State to provide necessary care to their patients. MSSNY issues memoranda of support or opposition to the Legislature where appropriate on hundreds of these bills. MSSNY lobbyists work with members of the Assembly, Senate and Governor's office to advocate for passage of legislation which the Society supports. We also work to assure that legislation opposed by MSSNY is not enacted or that it is amended to remove objectionable provisions.

For your review below is the record of all 212 legislators serving in the New York State Legislature with regard to a small but important subset of legislation which MSSNY has advocated for, or advocated against, during the 2009-2010 Legislative Session. We believe this information will be very helpful to you as you and your colleagues make your decisions regarding which candidates to support in the November general elections. We note that a few of the incumbent legislators listed below are not running for re-election. However, the vast majority Assemblymembers and Senators listed below are running for re-election.

The critically important legislation highlighted in this scorecard is as follows:

#### **BILLS MSSNY SUPPORTS**

- **A.6184/S.6799 and A.846/S.2723** - Would reduce medical liability premiums by enacting comprehensive medical liability reform including caps on non-economic damages.
- **Ch. 107 of the Laws of the 2010** – Reinstated the requirement that the Superintendent of Insurance review and approve health insurance premiums. Also increases the amount of funds that health insurers must spend on actual medical care. **A.3122 and A.8280/S.5470** sought to enact similar provisions.
- **A.4301/S.5204** – Would authorize independently practicing physicians to collectively negotiate with health insurance companies
- **A.3341 and A.9769** - Would enact omnibus managed care reform including prohibiting a health plan from determining a refund demand amount through extrapolation; requiring standardized health plan code review policies; and limiting unilateral contract amendments.
- **A.3171/S.5157 and A.766** – Would assure patients are able to assign payment to out of network physicians
- **A.10850/S.6189** – Would significantly reduce the ability of health insurance companies to make outrageous refund demands from physicians
- **Ch. 237 of the Laws of 2009** – Enacted omnibus managed care reform, including faster payment of claims, required notice of health plan fee schedule changes, faster credentialing and expanded time to submit claims

#### **BILLS MSSNY OPPOSES**

- **A.4627/S.1729** – Would expand the medical liability statute of liability to a “date of discovery” rule. Would increase medical liability premiums by over 15%
- **S.2872 and S.2391** – Would expand the types of damages awardable in wrongful death actions. Would increase medical liability premiums by 53%.
- **A.4656/S.8347** – Would expand the scope of practice of oral surgeon dentists to include all facial soft tissues
- **A.2518/S.2992** - Would expand the scope of practice of podiatrists from the foot to the ankle and all soft tissue structures below the knee
- **A.3718/S.2667** – Would permit optometrists to prescribe oral medications
- **A.6757** – Would authorize the awarding of pre-judgment interest in all tort actions. Would increase medical liability premiums by 27%
- **A.11487/S.8227** – Mandates primary care physicians to offer HIV tests to their patients age 13-64
- **A.7617/S.4498** – Mandates physicians to offer palliative care information to patients reasonably believed to have a terminal condition
